## ***LIST OF GENERAL REQUIREMENTS***

These items ARE subject to negotiation. We just ask that each item be thoroughly discussed prior to signing the contract and any changes MUST be in writing.

### **EQUIPMENT REQUESTS:** ( Circle what you can provide )

All equipment requirements and stage plot must be discussed and agreed upon by the Procurer and Booking Manager as soon as possible

For an event to go smoothly there will need to be a sufficient amount of time for setup. Load-in of all the equipment should begin AT LEAST three (3) hours prior to the start of the event to allow time for setup and a sound check.

### **GREEN/DRESSING ROOM:**

Procurer is to provide a private room/ area restricted to all except for band and crew only.

### **SECURITY:**

It will be the responsibility of the Procurer to provide reasonable assurance that our equipment, merchandise, and other belongings will be safe from both damage and theft. In cases where we are leading for an extended time (camps, etc.), we simply need to know the Procurer's plan for securing our property. **THE PROPERTY OF TOM GOLLY IS PROHIBITED FROM USE BY OTHERS WITHOUT PRIOR AUTHORIZATION**

### **PROMOTION:**

It is the responsibility of the Procurer to provide proper promotion of their event. This includes, but is not limited to radio, calendar listings, social media, and television. Tom Golly Music will reserve the right to self-promote for the event. Tom Golly Music will do our best, within reason, to provide photos or other resources necessary to aid in promotion.



## ***BASIC TECH REQUIREMENTS***

### **PRODUCTION:**

In the event Tom Golly Music is providing the Sound System, There is nothing you need to worry about.

We do ask that you can provide for us other than 2-4 Stage power outlets (preferably on Separate Breakers) and a few volunteers to help us load in and out.

### **PROCURER PROVIDED SOUND & BACKLINE:**

In the event Procurer is providing the PA system, All equipment requirements and stage plot must be discussed and agreed upon by the Procurer and Booking Manager as soon as possible

Tom Golly Music will provide THEIR OWN self contained & Controlled In Ear Monitor System as well as all personal and band backline equipment, stands and microphones for the performance. Except in special pre-discussed circumstances.

It is usually best for us to speak directly to the person in charge of the sound for your event prior to event.

### **LIGHTING:**

If event includes the use of stage lighting

Tom Golly Music requires the use of their own computer controlled lights, Truss and lighting system. All House lights and provided stage lights will need to be OFF during performance.

This setup uses HAZE Machines. Please be sure that your fire system is not hyper sensitive to haze. You may need to contact your local Fire Department to find out what precautions need to be taken to prevent a possible false alarm \*\*\*

## **MERCHANDISE:**

Tom Golly Music shall have the option to sell albums, t-shirts, or other merchandising material and shall retain 100% of the proceeds of such sales. An adequate space to do so shall be provided by Procurer

If any event requires an overnight stay we ask that the Procurer provide reasonable lodging for the band. Hotels, Cabins, and Host Homes are acceptable. If the Procurer chooses to provide a hotel Tom Golly Music will require (2) non-smoking double bed hotel rooms. ( accommodations for 4 )
